- Birth certificate (previous document)
- US birth certificate
- Proof of Indian blood degree
- US passport
- US Armed Forces ID card
- Certificate of Citizenship
- Naturalized Citizen card
- Foreign passport or Mexican Border Crossing card, with valid I-94

Bring additional documents

- Must be provided if the name on your birth certificate or previous document is different from the name on your driver license application:
 - Adoption documents with your signature as a result of the adoption
 - Name change documents with legal name letters and other name change
 - Marriage certificate
 - Certificate of naturalization or registration document with the signature of a naturalized citizen
 - Document of marriage document with your legal name as a result of the name change

Social security number

- The following documents are valid for proof of your social security number:
 - Social Security Card (must be original)
 - Medicare card
 - US Armed Forces Identification Card
 - Active DD Form 2 (must be original or certified copy)
 - Consular ID card
 - Agency identification document (ID #)

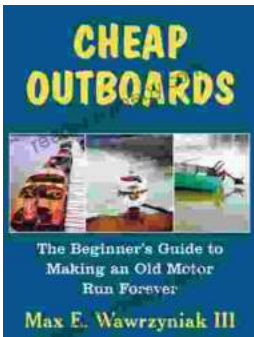
